Artist fees range \$100 to \$150 per hour. Artist can paint approximately 12 to 25 faces per hour depending on the intricacy of the designs that are chosen. If you exceed the time booked and we are available to stay, it will be charged in half hour increments. Client will pay for the time booked plus Overtime /even if Client has delayed the time we start the actual painting. Deposit Fee required to secure the date. All Charges are Due on the Day of the Event. Should a check be returned, there is a \$35 returned check fee. If paying with credit card and for online payments processing fee will be added.

Travel/Parking

Travel fees will apply when the event is more than 20 miles from zip code 75024. Depending on your event, there may be a charge for outdoor, lengthy or difficult setup - usually \$30. Please either leave a space open in front of the house on the street, the driveway, or a loading dock so Artist can unload equipment. The Client will reimburse Artists for any parking fees/ any fees are due on the day of the event. Client agrees to provide a map or detailed directions to event location.

Indoor Setup

Bathroom facilities, a minimum of 6' x 4' space and 20 minutes of setup and take down time is required. Please ensure that location has adequate lighting but we can bring lights if necessary - please let us know.

Options for Outdoor Setup

- 1. Client provide us with sun/wind/rain shelter and adequate space and lighting to paint.
- 2. Artist can bring our easy-up shelter, for an additional charge of \$30 for up to 2 Artist stations. We will need to set up 40 minutes prior to start / after completion of event in this case. We require a minimum of 10'L x 10'W x 11' H of level space, adequate lighting, access to a rest room and a place to dispose of our painting water. Please don't water your lawn on the day of your party, or soak it heavily the previous day if possible.

Weather (for Outdoor Events)

While Client can choose to pay for the Artist to bring a shelter, for the comfort of your guests and our artists, the client agrees to provide an area with protection from extreme temperatures, sun, rain, snow and excessive wind. Client is responsible to provide an **alternate indoor location** in the event of inclement weather. The client agrees to pay the full amount contracted once the painter has arrived at the event location, even if it is raining.

We do not offer refunds for inclement weather so please secure an alternate indoor location for your event in advance.

Cancellations / Refunds / Reschedule

The Deposit is non-refundable should the Client decide to cancel or postpone the event. In the case of postponement please notify us and we will work with you to accommodate an alternate date. However, due to the high volume of bookings, you may not receive your first alternate choice. Please notify us immediately of any changes.

If you cancel within 24 hours of you event you will own the total contracted amount on page 1.

Should your Artist get sick/ have to cancel, any deposits will be refunded, and we will find a replacement Artist.

Limitations On Artwork

If in public, artists will not paint on any part of the body that is not legal to expose or anyplace she does not feel comfortable painting. In addition, Artists will not paint subject matter she deems offensive or disturbing.

Breaks and Stop Time

Artists will have paid breaks of 5 minutes every two hours and access to a rest room. If you have booked by the hour, it is your responsibility to limit additional guests from requesting service after that time. Please book enough time to have all your guests painted to avoid this disappointment.

Extreme Adverse Working Conditions

Artist has the right to cease painting and leave without refunding any monies if there are extreme adverse working conditions and the Client fails to remedy the situation after it has been brought to the Client's attention. Adverse conditions included but not limited to: destructive, violent, or extreme inappropriate behavior of a child, pet or adult; illegal activities; or otherwise dangerous conditions.

Liability Statement

While we use ONLY FDA approved cosmetic grade face painting supplies, Artist is not liable for allergic reactions to paints. For safety reasons, Artists will not paint children under 2 years old; exception is made when parents acknowledge risk and if child is able to sit still enough to be painted. Squirming or upset children will not be painted. For sanitary reasons, Artists will not paint anyone who is or appears to the Artist to be sick, suffering from any skin condition or have open wounds. Artists is not responsible for damage to clothing or property. The Client agrees to pay for any accidents or injuries caused by pets or guests, and/or any damage to Artist's equipment or supplies caused by pets, lawn sprinklers, or guests. Under no circumstances will Artists supervise children. Their safety is the Client's and/or Parents' responsibility.

Face and Body Paints are made of US & EU compliant ingredients that are free of perfume, paraben, lanolin, beeswax or gluten. The paints are made without any animal based products and not tested on animals. The water based formula are specifically designed to be hypo-allergenic and safe to be used on sensitive skin.

All our equipment is kept scrupulously clean.

While we use ONLY FDA approved cosmetic grade Face and Body Painting products, Artist doesn't hold any liability for allergic reactions and for any health damage caused by our services. People with skin allergies or sensitive skin should either not participate or have Artist perform a patch test at the beginning of the party. It is Client's responsibility to alert the Artists about any allergies prior to being painted.

Our Water-Based Face and Body Paint is easily removed with soap and water.

Occasionally, when staining left behind using Micellar Water, Natural Oils or Makeup Remover is recommended. Cosmetic Glitter can be removed with baby oil any natural oil such as coconut or olive oil and rinsed out with water. Please, keep in mind that some paints may leave a light tint on the skin and should fade in a day or so.

Most of the products used for Face and Body Painting are Water-Based and washes off with mild soap and water. However, Alcohol-Based products are also being used for specific services. Client will be notified about any precautions and possible results.

Artist is not responsible and doesn't hold any liability for any property damage caused by our services. Some products that we use (including alcohol-based products) can leave stains on clothing and other objects. Artist will take reasonable care but if contact with paint does occur, the item should be cold soaked overnight in washing powder before washing normally.

Artists keep the right to refuse to paint anyone with restraining medical conditions, such as broken skin, open wounds, skin infection, cold symptoms, eye infections etc.

Artists will not paint without consent/against the wish of the person who's getting the service.

Artist has the right to refuse in creating offensive, violent or inappropriate content.

Artist has the right to leave without refunding any money if there are Extreme Adverse Working Conditions and the Client fails to remedy the situation after it has been brought to the Client's attention. Adverse conditions included but not limited to: destructive, violent and inappropriate behavior of a Client, pet or guests, illegal activities, or otherwise dangerous conditions.
